POSITION SUMMARY

Ontario Health is seeking expressions of interest from surgeons and radiologists for the position of **Provincial Clinical Lead for its Sector Support: Medical Imaging & Surgery** programs. This opportunity is open to all qualified candidates.

The Clinical Lead role was established to provide expert clinical advice and guidance to the Ministry, Medical Imaging and Surgery programs at OH in each specific surgical specialty and diagnostic imaging, under which data is being captured in the Wait Time Information System (WTIS).

OH is currently seeking Clinical Leads for each of the following areas:

- Clinical Lead: Oncology Surgery
- Clinical Lead: Diagnostic Imaging
- Clinical Lead: Urologic Surgery
- Clinical Lead: Vascular Surgery
- Clinical Lead: General Surgery
- Clinical Lead: Orthopaedic Surgery

ACCOUNTABILITIES

The Sector Support Clinical Leads will perform the following functions in relation to this area of expertise:

- Serve as a key advisor to the Ministry and OH on the development and execution of the strategic direction and goals for all OH initiatives related to surgical procedures or diagnostic imaging.
- Guide the identification, standardization, and collection of meaningful data considered valuable to stakeholders, in support of performance management accountabilities by leveraging evidenced-based data to make key resource decisions.
- Support surgical and diagnostic imaging recovery efforts across the province.
- Review data, provide clinical input and context in order to identify opportunities to reduce wait times and improve efficiencies (e.g., capacity issues, resourcing, equipment, etc.).
- Support ongoing clinical community engagement by:
 - providing advice on ongoing surgeon and radiologist adoption and compliance, particularly during new system deployments;
 - developing solutions to patient access issues; and,
 - following escalation processes to address ongoing problems with surgeons, hospitals, or Regions where issues have been identified.
- Act as a subject matter expert regarding clinical content improvements within the surgical area represented or diagnostic imaging.
- Serve as ambassadors between the clinical community, the Ministry, and OH.
- Help to ensure overall alignment between surgical and/or diagnostic imaging wait times and efficiencies and other provincial initiatives.
- Provide advice and participate in performance improvement initiatives for OH.
- Actively participate in the Advisory Committee's for both Medial Imaging and Surgery, quarterly data review meetings, and other ad-hoc meetings as required. Members will advise on items presented for discussion, review and provide feedback on materials drafted.
- Participate as required in speaking engagements and representation at public events.
- Provide input into the annual drafting of Ministry/Regions conditions of funding letters related to OH initiatives and requirements.
- Provide clinical expertise for the Ministry for any Quality Based Program (QBP) development/support work when applicable.
- Offer support and clinical guidance for new or ad hoc Ministry initiatives, related to their specialty as needed.

QUALIFICATIONS

Candidates for this role must, at a minimum:

- Be a practicing surgeon or radiologist holding a valid certificate of registration, and be in good standing with the College of Physicians and Surgeons of Ontario;
- Hold a valid certificate of registration as a practicing clinician in area being represented;

- Be recognized as a leader within the clinical community;
- Possess a minimum of five to seven years of experience in healthcare leadership positions with increasing responsibility in complex and dynamic organizations;
- Be able to maintain their existing clinical and administrative duties while assuming the Clinical Lead role;
- Be amenable to accepting the position for a minimum of two years;
- Be a champion for the use of information to measure, report and improve on performance; and
- Possess a thorough understanding of the Ontario Wait Time Strategy as well as the challenges faced during planning and implementation of large scale IM/IT initiatives in the healthcare sector.
