## **ACCOUNTABILITIES**

The key responsibilities of this role are:

- Provides strong, visionary leadership at the provincial level and scientific advice for the ColonCancerCheck (CCC) program.
- Collaborates with the Director, Program Design, the CCC manager, the CCC Clinical Lead and program staff to provide methodological guidance and input on scientific, data and analytical aspects of the program as well as the development of analyses to support program policy, design and management.

- Provide guidance on the development of indicators to measure the performance of colorectal cancer screening and GI endoscopy services in the province. At a minimum this includes:
  - o preparing a written dataset creation and analysis plan
  - o working with programmer/analyst to refine the plan
  - o providing expert guidance on the interpretation of results
  - o preparing written reports and manuscripts describing the results and
  - o providing guidance on the preparation of products (e.g., PowerPoint slides) describing the results.
- Provides guidance and input on program evaluation, monitoring and related reports.
- Provides guidance on strategic priorities for the development of datasets that support evaluation, monitoring and research relevant to the the CCC and GI endoscopy programs.
- Develops and implements research strategies to support policy, design and management of the CCC and GI endoscopy programs.
- Maintain up-to-date knowledge and understanding of published evidence related to colorectal cancer screening and GI endoscopy.
- Maintain up-to-date knowledge regarding performance measures from other jurisdictions related to colorectal cancer screening and GI endoscopy.
- Serve as Ontario's lead in national and international research collaborations with respect to colorectal cancer screening.
- Participates in expert panels and working groups and provides input into analyses to address questions arising from discussions with these groups.
- Pursue funding opportunities to support program evaluation and related research.
- Provide advice to the CCC program on resource utilization issues.
- Work with the scientific leads and Clinical Leads for Ontario Health's other cancer screening programs.

# **QUALIFICATIONS**

- PhD or Master's degree in epidemiology or related field, with at least 10 years experience.
- Expertise in population-based cancer screening programs.
- Understanding of colorectal cancer epidemiology (incidence, prevalence and mortality trends), cancer screening theory (pre-clinical disease, lead time, selection and length biases) and screening test characteristics (sensitivity, specificity, positive predictive value, etc.).
- Understanding of strategies for data collection and management (use of appropriate databases, linkage to appropriate registries, classification of screening outcomes, quality control procedures and data collection etc.).
- Experience in statistical analysis and interpretation of results (performance indicators, assessing screening impact and effectiveness etc.).
- Track record of peer-reviewed publications related to colorectal cancer screening research.
- Enthusiasm for, and commitment to, quality improvement in colorectal cancer screening and GI endoscopy at the provincial/system level.
- Experience in leadership positions at provincial, regional and/or local level.
- Knowledge of clinical, administrative and system issues with respect to colorectal cancer screening and GI endoscopy.
- Ability to analyze and interpret information, make sound decisions and communicate these to clinical and non-clinical audiences.
- Excellent interpersonal skills and ability to build consensus.
- Ability to work in a multi-disciplinary team.
- Knowledge and ability to facilitate knowledge transfer and education.

- Significant experience in presentation of data and report writing.
- Knowledge of current and new/emerging colorectal cancer screening and GI endoscopy guidelines.
