## POSITION SUMMARY

Ontario Health is seeking expressions of interest from clinicians with focused practices in the management of hematologic cancers for the volunteer position of Member, Hematology Disease Site Drug Advisory Committee.

The Hematology Disease Site Drug Advisory Committee will provide timely evidence-based clinical and health system guidance on drug-related issues in support of the Provincial Drug Reimbursement Programs (PDRP) and the Systemic Treatment Program.

## ACCOUNTABILITIES

- Identification and prioritization of drug funding gaps that needs to be addressed.
- Contribute to planning and preparation of drug submissions (in-Ontario or pan-Canadian) and other provincial funding applications.
- Provide annual horizon scanning updates on new/emerging treatment options. Highlight issues that are expected to affect existing drug funding pathways.
- Provide clinical and/or health system advice on
  - pan-Canadian or local drug submission and review processes (e.g., Canadian Agency for Drugs and Technologies in Health (CADTH) Drug Reimbursement Reviews, Ontario Steering Committee for Cancer Drugs)
  - drug funding implementation and knowledge transfer activities
  - activities related to the Systemic Treatment-Quality-Based Procedure
  - other program initiatives

- Provide case-specific adjudication advice, and more general disease management advice to OH-CCO to support the administration of its funding programs (including the New Drug Funding Program).
  - Monitor and re-evaluate on an ongoing basis, drugs reimbursed by the publicly funded programs with regard to their continued therapeutic value and cost effectiveness.

## QUALIFICATIONS

- Be in active practice and/or engaged in research in either the community, hospital, or academic setting in the following capacity:
  - Hematologist (2)
- Demonstrated commitment to patient-centred care and public accountability.
- Have a commitment to evidence-based medicine and interpretation of quantitative data.
- Not employed by a pharmaceutical or related company

Effort will be made to ensure province-wide geographical representation and representation from academic and community practices.
